Membership Subscriptions Guidance Notes 2019/20

Annual Membership fees **£100.00**
 £ 90.00 (unwaged)

Half year Membership **£ 50.00**
 £ 45.00 (unwaged)

The annual membership subscriptions are due for the membership year 2019/20. The subscription fee can be paid in a single one-off payment (cheque or cash) or it can be paid in instalments using a standing order with your bank. Members choosing to pay by instalments as are asked to use one of the following three plans.

10 Month Plan

Ten monthly payments of £10.00 (£9.00 unwaged) made via standing order with the first payment commencing October and the final payment in July.

Quarterly Plan

Four payments of £25.00 (£22.50 unwaged) made via standing order in the following months - October/January/April/July

Six Month Plan

Two payments of £50.00 (£45.00 unwaged) made via standing order in the months of October and April

Members are asked to note:

1. That a 12 monthly instalment plan is not recommended. This is primarily because it is not usually possible to set up a monthly plan early enough to ensure that the membership subs are fully paid within the current financial year (01/08/19-31/07/20) as is required. Other time limited plans are offered which meet the payment criteria and also safeguard against payments remaining in place after the membership period when an individual chooses not to renew their membership for the subsequent year.
2. Instalments by personal cheque or cash payments are not accepted. Cash or cheques will only be accepted as a one-off payment of the total fees due for the Year (or half year).
3. Half year fees are for those joining after January in a given year for participation in the summer concert/show. These fees are due in one single payment.
4. All subscriptions (Full and half year) are levied to underwrite the main activities of the Society these are not show fees.
